- Distil stakeholder engagements into insights and develop appropriate action plans
- Ensure greater stakeholder understanding of TASEZ and its role ensuring inclusive economic participation
- Identify potential risks that could jeopardise the project and develop appropriate interventions

Contribute to the Development of Programmes

- Develop and implement a cohesive, effective community engagement strategy to manage and influence community perceptions and enhance TASEZ brand in line with the organisations' integrated marketing communication strategy
- Establish fluent relationships with the right community decision-makers and influencers to contribute to the organisation's strategic objectives

Community Buy-In

- Promote TASEZ to relevant stakeholders to ensure overall community buy-in
- Ensure that stakeholder engagements are efficient to minimise misinformation

- Develop effective feedback mechanism based on community engagements programmes and provide regular reports to the Marketing and Communications Department for inclusion in corporate campaigns

Compliance, Monitoring and Reporting

- Monitor and evaluate the effectiveness of approved community engagement strategy and implementation plan
- Write and submit quarterly reports as set out in the contracted performance measurement and business plan scorecard of the organisation
- Manage and report on budget spend in accordance with the approved project plans
- Support the organisation by providing relevant community-based information when needed
