1. Introduction

1.1. TASEZ promotes, develops, operates and manages a Special Economic Zone (SEZ). The primary driver of the SEZ is the expansion of automotive manufacturing capacity in the City of Tshwane. In 2016, a master plan for Silverton Industrial and Retail Park was developed to offer a diversity of appropriate land uses and other economic activities. The Plan that was developed spans over 224 hectors that include four (4) development phases, of which Phase 1, 1A and 2 is on 81.6 hectors of Tshwane owned land for the development of an automotive supplier park.

- 1.2. The planning and eventual construction and operation of the SEZ represent the legal trigger for the Environmental Impact Assessment (EIA) process to follow in terms of the List of Activities and Competent Authorities identified in terms of Sections 24 & 24D of the National Environmental Management Act (Act No. 107 of 1998) (NEMA).
- 1.3. The immediate areas surrounding the site are:
 - 1.3.1. Northern and Eastern Boundary:The Moretele View; Naledi and Nellmapius residential neighbourhoods as well as the Mamelodi Hospital.
 - 1.3.2. Southern Boundary:

The Nellmapius residential neighbourhood; clinic and a large plot of undeveloped land.

1.3.3. Western Boundary:

The Ford Motor Company South Africa and Watloo Industrial area

- 1.4. The development of phase 1 has been completed whilst the development of phase2 is planned to commence in 2025.
- 1.5. TASEZ aspires to ensuring "Zero Harm" by implementing its SHE (Safety, Health and Environmental) Policy, where TASEZ has committed to protect the environment and prevent environmental pollution in order to ensure that its activities have positive impact on the environment by eliminating and/or mitigating environmental aspects.
