3.1. SCOPE OF WORK

 Tasez wishes to appoint Three experienced service providers to execute a three-year maintenance services plan and repairs on call-out basis and on a rotational basis for the Access control system below:

- 10 x turnstiles
- 11 x Spikes barriers (4X3 Meters and 8X4 meters)) and
- 14 x boom-gates.

This includes all minor and major services in accordance with statutory requirements and manufacturer recommendations.

3.1.1 Detailed Specifications/Scope of Work

- 3.1.2 Maintain and repair boom gates (14), turnstiles (10) and spike barriers (11) at Tasez Zone Operation Phase 1 and Phase 1A for the period of 36 months.
- 3.1.3 A valid certificate of compliance shall be provided for all repairs.
- 3.1.4 All equipment to be supplied during repairs must have a minimum warranty of 3 (three) years.
- 3.1.5 The Service provider must explicitly articulate the warranty duration on all equipment to be supplied.

- 3. In the event of a conflict between the Bidder' proposal and the SLA concluded between the parties, the SLA will prevail.

20. Preparation Costs

21. Indemnity

If a Bidder breaches the conditions of this RFP and, as a result of that breach, TASEZ incurs costs or damages (including, without limitation, the cost of any investigations, procedural impairment, repetition of all or part of the RFP process and/or enforcement of intellectual property rights or confidentiality obligations), then the Bidder indemnifies and holds TASEZ harmless from any and all such costs which TASEZ may incur and for any damages or losses TASEZ may suffer.

22. Precedence

This document will prevail over any information provided whether oral or written, unless such written information provided, expressly amends this document by reference.

24. Tax Compliance

25. RFP Defaulters and Restricted Suppliers
